GLACIERS MEMBERSHIP AGREEMENT

ELIGIBILITY

At the discretion of the management of Glacier Club, a limited number of Individual and Family memberships are available to the general public without discriminatory regard to race, creed, religion or national origin. Prospective purchasers must complete an application and acknowledge understanding of all terms, policies, and conditions contained herein. Dependents 18 years or younger living with the Glaciers member may be added to a family membership or may be considered the second party of a family membership. The management of Glacier Club reserves the right to cancel or amend this offer at any time without notice. The management also reserves the right to revoke a Glaciers membership for a member's violation of contract terms, and or golf club and clubhouse rules and policies.

RESERVATIONS & CANCELLATIONS

Glaciers members may reserve any starting times up to 14 days in advance. Starting times made by members not canceled at least 24 hours in advance of play will result in loss of playing and range privileges for 2 weeks.

PRACTICE PRIVILEGES

Complimentary practice balls are available to every member. Member's wishing to use practice balls or any practice area without the benefit of a starting time may do so at the discretion of the golf club staff on duty. Members must check in with the golf shop staff before proceeding to any practice area. Failure to check in may result in suspension of practice privileges or loss of membership. Members are not to share their practice balls with non-members; any member caught in violation will lose all practice privileges.

CHECKING IN

To maintain the integrity of play administration, all players must register in the golf shop at least 10 minutes prior to a reserved starting time. Failure to do so may result in a cancellation or delay if other parties are prepared to play or are on standby. Forced cancellations will be charged in accordance with the 24-hour cancellation policy if standby players do not fill the starting time.

AVAILABILITY OF FACILITIES

The management of Glacier Club reserves the right to host special events such as weddings, parties, and golf tournaments. Such events may partially restrict the availability of golf course starting times and any or all of the practice areas. Such special events also may preclude the use of the clubhouse dining areas. Any or all practice areas also may be unavailable from time to time because of inclement weather or maintenance practices.

TERMS & RENEWAL

The term of any 2011 Glaciers membership begins March 1, 2011 and expires December 31, 2011. However, memberships bought before the published effective dates are effective from the date of purchase through the published expiration date at no increased annual fee.

TRANSFERS & REVOCATIONS

Membership privileges are personal to the member and may not be sold, transferred, or otherwise assigned in any manner. Privileges shall cease and terminate upon the death of the member(s). Any fees paid are non-refundable. The management of Glacier Club may revoke any membership if a member violates any terms of this contract agreement, which may change from time to time. No portion of any fees paid is refundable upon revocation of a membership.

GOLF CLUB MANAGEMENT

Policies and procedures are established and administered by the Golf Club management, including but not limited to the general manager, head golf professional, food and beverage director, golf staff, and others so designated by the Golf Club. Glaciers Golf Club is a privately owned, daily-fee golf course. Glaciers membership in no way conveys any rights of golf club membership or ownership.

GUIDELINES

Junior memberships are available for any player 18 years & younger.

Family members are for husband/wife and 2 dependants living in household under the age of 18. (Copy of birth certificate required)

CORPORATE

Corporate memberships are not valid for leagues or outings. The membership may be used by employees or customers of the corporation. The guests playing must be in possession of the membership cards. Only four corporate members are allowed on the course at a given time.
